The above matter refers.

We continue to receive correspondence from Judges, Judicial Officers and Law Society of Kenya (LSK) Branches regarding the facilitation of pauper briefs and pro-bono services and the challenges faced by advocates. It is evident that these issues require immediate attention and quick resolution.

As mentioned in our letter dated 31st May, 2023, we have established a committee comprising representatives from the Judiciary and the Law Society of Kenya to help us addressing the issues. The LSK has graciously nominated two members to be part of this committee, with the objective of thoroughly examining the issues and devising an agreeable solution.

This letter is therefore, to request your assistance in communicating to the members of the Society, urging them to allow the Committee to engage on the matters. We believe that a thoughtful and inclusive approach is necessary to address the concerns effectively.

Further, we request you to encourage your members to continue accepting briefs and fulfilling their obligations in the cases already undertaken, as this is essential for promoting and upholding access to justice. In the meantime, we have disbursed Twenty Seven Million, Five Hundred and Twenty Five Thousand Shillings (Kshs.27,525,000/=) as per the attached list.

We look forward to expeditiously finding suitable solutions that will benefit all stakeholders and we thank you for your continued support.
